Initial accreditation in the Idaho Pro-Logger Program is established when the core components are completed and an application into the program has been made. Once accredited, the participant in the Idaho Pro-Logger Program must complete 12 continuing credits, 4 of which have to be the OSHA required Logging First Aid & Safety class, each calendar year to retain accreditation status. While most courses for continuing credits are available and completed in the spring of the year, there are classes available year-round and accreditation status can change.

About The Idaho Pro-Logger Program

In 1998 the Idaho Pro-Logger Program was initiated in order to meet the educational needs of Idaho logging contractors, loggers, forest owners and forest products companies. Secondly the program seeks to meet the requirements of the Sustainable Forestry Initiative (SFI) and similar forest land certification programs. An advisory committee consisting of logging contractors, forest owners, representatives of forest products companies, foresters, the University of Idaho Extension Forestry Department, the Idaho Department of Lands, advisors from the Idaho Logging Safety Program, and the Associated Logging Contractors meets regularly to monitor and guide the program. The Idaho Pro-Logger Program is owned and operated by the Associated Logging Contractors of Idaho (ALC).

ARE YOU AN ACCREDITED IDAHO PRO-LOGGER (IPL)?

Have you:

1. Completed a **THREE (3) Day LEAP class? (24 Credits) Must enroll within three (3) years of completing.**
2. Completed **Logging First Aid & Safety Training that is presented by State of Idaho Logging Safety & Associated Logging Contractors? REQUIRED EVERY YEAR! Four (4) Credits. (SIGN YOUR NAME CLEARLY)**
3. Completed the **IPL Application/Enrollment form with the ALC Office? (You are NOT automatically enrolled in the IPL program when you complete the 3 Day LEAP)**
4. Completed **eight (8) additional IPL approved credit classes/events? REQUIRED EVERY YEAR After completion of LEAP. (SIGN YOUR NAME CLEARLY)**
5. **If not an ALC Member have you paid your ANNUAL IPL Fee?**

After the initial LEAP class is complete you must have twelve (12) IPL credits per year with four (4) of those being Logging First Aid & Safety EVERY YEAR.
